

STUDENT ROUTE VISA HOLDERS: YOUR OBLIGATIONS

ACADEMIC YEAR 2023-24

STUDENT VISAS: IMPORTANT INFORMATION, PLEASE READ CAREFULLY.

This document has information about enrolment and attendance, updating your personal details and contact or address details, working in the UK, changing your course, suspension or withdrawal, exam failure or deferral, and changing immigration status during the course.

YOUR OBLIGATIONS AS THE HOLDER OF A STUDENT ROUTE VISA

It is extremely important that you always comply with the conditions of your student visa.

If you do not comply with your visa conditions, you may have to stop studying and return to your home country, the Academy may have to cancel your visa sponsorship, you could get a criminal record, or you could be denied entry to the UK for a number of years.

Please help us by telling us of any **changes in your circumstances** (for example, your UK address, mobile phone, personal email, your name...).

YOUR RESPONSIBILITIES TO THE ACADEMY AND TO UKVI, AND WHAT TO DO IF YOUR CIRCUMSTANCES CHANGE:

BRP: When you arrive in the UK on a temporary travel vignette, you must collect your Biometric Residence Permit (BRP) from the nominated Post Office within 10 days of arrival, or before the expiry date of the vignette, and bring it to be checked and copied by the Registry staff.

- If you have an electronic visa (e-visa), you will not have a vignette or BRP so you need to send us a ShareCode to prove your immigration status.

Make sure the information on your BRP or electronic visa is correct, and tell UKVI and the Academy if there is a mistake.

For example, if it expires too early, or has the wrong working conditions on it.

Your personal details: You must always keep your contact and personal details up-to-date with the Academy. Please email registry@ram.ac.uk to update us if you change your UK address, private email address or mobile telephone number.

Immigration details: If you receive a new passport or student visa extension, or change to a different visa during your studies, there are two things you must do:

- Immediately bring these documents to the Registry, so that we may update your student record.
- Tell UKVI - You **must additionally notify UKVI** yourself if you change any **contact or personal details**, especially your email. The Academy cannot do this for you.

It is your responsibility to abide by the conditions of your student visa (including the restrictions on the type and duration of work you can do in the UK) and to make sure you do not stay beyond the expiry date as stated on your visa, unless you have made a renewal application. If you break your conditions, you could be prosecuted or made to leave the UK. This could make it more difficult for you to get another visa in the future.

ENROLMENT

When you enrol at the Academy, Registry staff will check copies of your **passport and visa/BRP** that you upload to your electronic student record.

DURING YOUR STUDIES

Attendance: The Academy keeps attendance records for all students. However, in the event of a UKVI audit, we will need to show them your attendance record, and demonstrate that you have not been absent without good reason.

If you are going to miss a class due to sickness or any other reasonable circumstance, please let your teacher know.

If you are going to be away from the Academy for an extended period of time - you must inform your Head of Year (undergraduates) or Tutor (postgraduates) and get Leave of Absence. If you are unexpectedly missing and we can't contact you, we have to tell UKVI. If we already know that you will be away for an extended period of time, then we will not need to contact you to check this.

Change immigration status – If your Immigration status changes whilst you are studying from a Student Route visa to another visa type [for example, a Dependant visa or a Tier 1 visa] or if you get Indefinite Leave to Remain in the UK, please email admissions@ram.ac.uk or take your new documents to the Registry immediately so that your student record can be updated.

You are expected to live within reasonable travelling distance of the Academy, and when your course has finished you are expected to leave the UK before the expiry of your visa, or apply for a further leave to remain – that means getting another valid visa for staying in the UK.

WORKING IN THE UK

You must read the advice in the UKVI Migrant Guidance if you wish to **work in the UK** (paid or unpaid), so you do not break your work restrictions. **This includes musical performances!** You must ensure that the work is permitted according to the restrictions on your visa. If you are offered performance work outside the Academy, it must be booked through the Academy. THE ACADEMY'S RESPONSIBILITIES AS YOUR VISA SPONSOR:

- We are required to inform UKVI if you **suspend your studies, transfer course, withdraw from a course, or complete your studies significantly early.**
- If you **fail to enrol** at the start of your course or in a subsequent year, we have to inform UKVI.
- We have to inform UKVI if you are **absent for an extended period** and we have been unable to contact you or find out the reason.
- We are required by UKVI to **check your student visa and passport ID page** when you first arrive, to keep copies on your student record, and to update these details during your studies if you obtain a new passport or a new visa, or if you get additional UK immigration stamps.
- We have to inform UKVI if we learn that you are **not abiding by the conditions of your visa.**

If you change your student status during your course

*Please note that any change in your student visa status, particularly if you stop studying, may affect your **working entitlement**. If you are working you should seek advice and notify your employer of the change of circumstance immediately.*

- *Suspension of studies*

If you suspend your studies for personal or academic reasons (e.g. illness, pregnancy, financial reasons) then UKVI expects you to return to your home country unless you are not medically able to do so, and you must give the Academy photocopies of your travel documents to prove that you are leaving the UK. If you hold a Student Route visa (issued via a Confirmation of Acceptance for Studies (CAS) number) the Academy is obliged to report your suspension to UKVI who may cancel your visa. [However, UKVI realises you may not be able to return home immediately if you are very ill or in the late stages of pregnancy.] You may need to get independent legal advice about an alternative immigration status if you need to remain in the UK for an extended period because of illness.

You will need to apply for a new CAS number and student visa from your home country before you return to the UK to resume your studies.

- *Transfer of course within the Academy*

If you hold a Student Route visa (issued with a CAS number) then the Academy must inform UKVI that you have changed course. If your new course is shorter (for example, switching to a 1-year MA from a 2-year MA) your visa length will be reduced and you must also contact UKVI about your new study dates: the email address you should use is migrantreporting@ukba.gsi.gov.uk. If your new course is longer than the original course, you will need to make an application to

extend your visa before your current one expires and you may have to return to your home country to do this.

You cannot switch to the new longer course if your existing immigration permission expires before the course end date; for example, if you join the 1-year MA and ask to switch to the 2-year MA, you cannot be put on the 2-year MA until you have returned home and updated your visa with additional time (that should be done during the Christmas vacation and you will need a new CAS).

- *Examination failure*

If you fail an exam in the summer and can retake it again before the beginning of December, you can remain in the UK to take the resit examination, and if necessary can extend your visa. If you fail an exam in the summer and cannot retake the exam (to continue your studies) until the next Spring or Summer term, your studies are considered to be suspended and you will need to return home. If you hold a Student Route visa (issued via a CAS number), the Academy will inform UKVI who will normally curtail your visa. You will then require a new CAS and student visa to return to the UK to recommence your studies.

- *Examination deferral*

If you defer your Final Recital or other exam which then has to take place after the expiry of your Student Visa, you will need to leave the UK before your visa expiry, and return with a Standard Visitor visa to take the deferred exam.

- *Withdrawal from course*

If you hold a Student Route visa (issued via a CAS number) the Academy must inform UKVI if you withdraw from your course. If you have more than six months remaining on your current student visa then UKVI will curtail that visa; you will be expected to leave the UK with 60 days of withdrawal and you immediately lose your right to work in the UK.

You must send the Academy copies of your travel documents to prove that you are leaving the UK [or, if you are changing to another institution or another visa status, copies of the relevant documentary proof].
